Your proposal should contain, but not be limited, to the following considerations:

1. Proposals will be accepted from qualified individuals and organizations.
2. The proposals should provide a detailed description and outline of the services to be provided.
3. The individual's or organization's experience in their proposed area of services.
4. Proposals will be accepted for individual or an inclusive curriculum, but must cover the areas of science, technology, engineering, and mathematics.
5. Your staff assignments (if applicable) and your ability to provide detailed and timely reporting.
6. Proposals Should provide a 6-week minimum of programming.
7. Field Trips are acceptable and will be coordinated with the center's management team (Transition is available through the Beulah Community Family Life Center)
8. Proposals should include a detailed cost analysis of the programming being offered.
